**Terms of Service**

1. Introduction

Welcome to Oksuro. By accessing or using our website and services, you agree to comply with and

be bound by the following terms and conditions. Please read them carefully.

2. Definitions

**Service**: Refers to the Oksuro website and any services provided through the website.

**User**: Any individual who accesses or uses the Service.

**Membership**: Access to exclusive content and features provided to registered users.

• Personal Data: Information relating to an identified or identifiable natural person as defined by

GDPR.

  download isn't available, clicking the download button will trigger a popup notifying you of the
  restriction.
- All downloaded images are recorded in your Download History on your Dashboard, allowing
  you to track your downloads for easy reference and future use. Even if an image is deleted, the
  download record will remain in your history indefinitely.
- The list will indicate that the image has been deleted, but the record itself will stay.
- Oksuro disclaims any liability for copyright or legal issues that may arise from the use of downloaded images. Users are responsible for ensuring the lawful use of downloaded images in line with applicable laws and Oksuro's License terms.

# 7. Sharing Al-Generated Images

Oksuro provides a platform for sharing Al-generated images and associated prompts and settings. By using the Service, you agree to:

- Ensure your use of images complies with the applicable licensing agreements of the AI tools used to generate them.
